







**Notice on the Continuation of the National Emergency
Concerning the Coronavirus Disease 2019
(COVID-19) Pandemic**

FEBRUARY 18, 2022

On March 13, 2020, by Proclamation 9994, the President declared a national emergency concerning the coronavirus disease 2019 (COVID-19) pandemic. The COVID-19 pandemic continues to cause significant risk to the public health and safety of the Nation. For this reason, the national emergency declared on March 13, 2020, and beginning March 1, 2020, must continue in effect beyond March 1, 2022.

Therefore, in accordance with section 202(d) of the National Emergencies Act (50 U.S.C. 1622(d)), I am continuing the national emergency declared in Proclamation 9994 concerning the COVID-19 pandemic.

This notice shall be published in the *Federal Register* and transmitted to the Congress.

The National Emergency Declaration: What you need to know

Here are 16 Emergency Powers the President of the United States has while the declaration is in effect:

1. Bank Accounts can be frozen
2. Bans on biological or chemical agents can be lifted
3. Civil liberties, such as the right to a peaceful assembly, can be halted
4. The President can order incarcerations
5. Elections can be postponed Indefinitely
6. Federal leases can be suspended when the country faces danger
7. Foreign individuals can be ordered to leave the nation and borders can be closed
8. National resources can be ushered into play to confront a national disaster
9. Sanctions pertaining to property and finances can be removed or initiated
10. Soldiers and naval vessels may be ordered to engage in combat during a crisis
11. The government can take control of the internet, radio, and TV because of a perilous matter and production and distribution of goods can be seized
12. The military can be mobilized domestically in a crisis, martial law can be declared by the president
13. The leader of the executive branch can launch a nuclear strike if necessary
14. The president may order an assassination resulting from emergency
15. The right of habeas corpus can be suspended as a consequence of crisis
16. Transportation can be taken over by the government... and



Stated Official Bilderberg History:

Bilderberg Meeting is an annual conference designed to foster dialogue between Europe and North America. Every year, between 120-140 political leaders and experts from industry, finance, labor, academia, and the media are invited to take part in the Meeting. About two-thirds of the participants come from Europe and the rest from North America: approximately a quarter from politics and government and the rest from other fields. The Bilderberg Meeting is a forum for informal discussions about major issues. The meetings are held under the Chatham House Rule, which states that participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s) nor any other participant may be revealed. Thanks to the private nature of the Meeting, the participants take part as individuals rather than in any official capacity and hence are not bound by the conventions of their office or by pre-agreed positions. As such, they can take time to listen, reflect and gather insights. There is no detailed agenda, no resolutions are proposed, no votes are taken, and no policy statements are issued. (So, they say...)

White Flag of Temporary Truce In Order To Parley (negotiate)

The white flag is an internationally recognized protective sign of truce or ceasefire, and request for negotiation. It is also used to symbolize surrender, since it is often the weaker military party which requests negotiation. A white flag signifies to all that an approaching negotiator is unarmed, with an intent to surrender or a desire to communicate.

Persons carrying or waving a white flag are not to be fired upon, nor are they allowed to open fire. The US Department of Defense Law of War Manual article 12.4 and 12.5, briefly addresses specific rules that relate to the rights, duties, and liabilities of persons in the various classes to illustrate and provide an overview of that class.

WHY U.S. CODE TITLE 18 SECTION 241 & 242 MATTERS

UNDERSTAND YOUR LEGAL RIGHTS WHEN EXERCISING YOUR CONSTITUTIONAL RIGHTS


These codes may be invoked to law enforcement or any persons when they attempt to **COERCE**, **FORCE**, or **THREATEN** in your application and demonstration of your U. S. Constitutional rights.

TITLE 18, U.S. CODE SECTION 241

CONSPIRACY AGAINST RIGHTS

If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or If two or more persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured— They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death.





TITLE 18, U.S. CODE SECTION 242

DEPRIVATION OF RIGHTS UNDER COLOR OF LAW

The act of a state officer, regardless of whether or not the act is within the limits of his or her authority, is considered an act under color of law if the officer purports to be conducting himself or herself in the course of official duties.

Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such person being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.

TITLE 18, U.S. CODE SECTION 2331 SUBSECTION 802

We the People have been **COERCED** by the U.S. government, state governments, municipalities, private industries, medical facilities, and employment to take an experimental drug under duress that has involved acts dangerous to human life. These people and institutions that have threatened and coerced We the People of the United States to take the covid "vaccine," are by the very definition, guilty of Domestic Terrorism upon the American citizenry and should be charged accordingly in the United States Federal Courts.

(5) the term "DOMESTIC TERRORISM" means activities that—

(A) involve acts dangerous to human life that are a violation of the criminal laws of the United States or of any State;

(B) appear to be intended—

(i) to intimidate or coerce a civilian population;

(ii) to influence the policy of a government by intimidation or coercion; or

(iii) to affect the conduct of a government by mass destruction, assassination, or kidnapping; and

(C) occur primarily within the territorial jurisdiction of the United States.

TITLE 21, CFR SECTION 50.23

IT IS ILLEGAL TO MAKE ANYBODY PARTICIPATE IN AN EXPERIMENTAL PROGRAM USING COERCION AND WITHOUT INFORMED CONSENT.

That is how the Nuremberg Code was embraced in U.S. law. They must obtain informed consent before use of any test article...ie. covid "vaccine" under emergency authorization use. We the People do not accept that we have given consent and have We the People of these United States have been coerced to take such test article under false pretenses of what is considered informed. The exception from general requirements under TITLE 21, CFR SECTION 50.23 have not been met, in order to warrant otherwise.

§ 50.23 EXCEPTION FROM GENERAL REQUIREMENTS

(a) *The obtaining of informed consent shall be deemed feasible unless, before use of the test article (except as provided in paragraph (b) of this section), both the investigator and a physician who is not otherwise participating in the clinical investigation certify in writing all of the following:*

(1) *The human subject is confronted by a life-threatening situation necessitating the use of the test article.*

(2) *Informed consent cannot be obtained from the subject because of an inability to communicate with, or obtain legally effective consent from, the subject.*

(3) *Time is not sufficient to obtain consent from the subject's legal representative.*

(4) *There is available no alternative method of approved or generally recognized therapy that provides an equal or greater likelihood of saving the life of the subject.*

When you are met by someone who is attempting to **COERCE** you to take the covid "vaccine" you should record it, then ask the individual if they are comfortable violating **TITLE 21 CFR SECTION 50.23** as a civil violation of the law? If you receive a yes...then ask the individual if they are then willing to violate **U.S. CODE TITLE 18 SECTION 2331 SUBSECTION 802**? If that is another yes, you may now inform them that they just violated the law and it falls under domestic terrorism.
